Dear Minister McMeekin:

Access to safe, decent and affordable housing is fundamental to ensuring a good quality of life for Ontario residents. However, at present, municipalities do not have the tools to create sufficient housing, including regulatory powers to enact inclusionary zoning policies. Many Ontario municipalities, planners, community organizations, housing advocates, and people across Ontario have been calling for the policy change for a long time. However, the Province has yet to pass the necessary legislation.

There are currently more than 168,000 households on waiting lists for affordable housing in Ontario and thousands more depend on our shelter system every day. It is no secret that there is an affordability crisis at hand, not only for lower income families, but also for a growing portion of the middle class. Consequently, municipalities need every tool in the policy toolkit to address urgent housing needs. Inclusionary zoning is a very important tool with a proven track record in providing much needed housing in hundreds of municipalities across North America. According to Toronto's Chief Planner, we could have built more than 12,000 affordable housing units in the last five years in Toronto alone, had the Province permitted inclusionary zoning. Strikingly, there could have been an additional 1,200 affordable housing units created in Toronto since the estimates were made by the Chief Planner in May 2015, had fast response been given to our repeated requests. Cities and regions across Ontario recognize the potential of inclusionary zoning policies and have called on the Province to act.

We were pleased to hear you state, in the Legislature on November 16th of last year, that people who were eager to see inclusionary zoning would be waiting "not much longer" for the legislation to come forward. We want to urge you to act on that promise. We are missing a big opportunity. We need this government to listen to the many voices calling for this important

policy change and facilitate the creation of more affordable housing for the thousands of Ontarians that are desperately in need. We can't wait until next year, until the next housing strategy or until the next government. We need to move forward. And we can.

There are already two bills [Bill 3 and Bill 39] before the legislature to easily provide inclusionary zoning powers to municipalities. The Ontario government needs to adopt inclusionary zoning legislation urgently before the current sitting of the legislature ends. Ontarians need inclusionary zoning powers before the summer, and there is no reason not to provide it.

We once again ask for your leadership to bring forward either of the bills on inclusionary zoning so that municipalities can have the authority to implement inclusionary zoning and build desperately needed affordable housing.

We look forward to your response on this critical issue.
